INFLECTIONAL VS. DERIVATIONAL

Inflectional Morphemes

- **-er** (comparative: taller)
- **-est** (superlative: tallest)

Inflectional morphemes always come at the end of a word and are governed by syntax. They indicate tense, number, gender, case, or degree. A key insight for **understanding morphology** is that inflection never creates a new word; it only creates a different version of the same word.

Derivational Morphemes

Derivational morphemes, on the other hand, create new words. They can change the meaning or the part of speech of the base word. For example, adding "-tion" to "inform" (a verb) creates "information" (a noun). Adding "un-" to "happy" (an adjective) creates "unhappy" (a different adjective with a negated meaning). Initialisms
