THE MAN WHO KNEW INFINITY: THE ENDURING GENIUS OF SRINIVASA RAMANUJAN

Despite failing his college exams due to his single-minded focus on mathematics, Ramanujan never wavered. His hunger for recognition led him to write letters to prominent mathematicians in England. Most ignored him, but one did not: the eminent Cambridge mathematician G. H. Hardy.

Hardy famously described Ramanujan's letter as containing theorems that

“defeated me completely; I had never seen anything in the least like them before.” Recognizing a genius of the highest order, Hardy arranged for Ramanujan to journey to Cambridge in 1914. This was a monumental decision for a devout Brahmin who had never left his home country. At Cambridge, the collaboration between the intuitive, untrained genius and the rigorous, analytical Hardy produced some of the most significant mathematical results of the early 20th century.

Contributions: The Enduring Legacy of Ramanujan's Work

To understand **Srinivasa Ramanujan and his contribution to mathematics**, one must look beyond specific formulas and appreciate his unique approach. He operated on intuition, claiming that the Hindu goddess Namagiri would whisper equations to him in his dreams. While

Furthermore, Ramanujan discovered surprising congruences for partitions, such as the fact that the number of partitions of a number ending in 4 or 9 is always divisible by 5. These "Ramanujan congruences" hinted at deep, hidden structures in the theory of numbers that mathematicians are still exploring with

modern tools like modular forms.

2. THE LAND OF INFINITE SERIES AND CONTINUED FRACTIONS

Ramanujan possessed an uncanny ability to manipulate infinite series and continued fractions. He produced hundreds of identities that equated complex infinite sums to simple constants like π . One of his most famous results, now known as the **Ramanujan-Sato series**, converges to π at an astonishingly rapid rate. Each new term in these series adds many digits of accuracy, making them incredibly efficient for calculating π to trillions of digits. Indeed, many of the algorithms used in modern computers to compute π are based on Ramanujan's work.

His work on **continued fractions**, expressions of the form $a + 1/(b + 1/(c + 1/(d \dots)))$, was equally profound. He discovered elegant relationships between these fractions and special functions, particularly in the analysis of the Rogers-Ramanujan identities, which he rediscovered independently. These identities, connecting partitions and infinite products, are considered some of the most beautiful and mysterious formulas in all of mathematics.

3. THE THETA FUNCTIONS AND MOCK THETA FUNCTIONS

Perhaps his most mysterious legacy is found in his work on **theta functions**, which are essential tools in the study of modular forms, algebraic geometry, and even string theory. Ramanujan made

deep contributions to their theory. However, the real enigma lay in what he called **mock theta functions**. In his last letter to Hardy, written from his deathbed in 1918, Ramanujan described seventeen strange functions that behaved like theta functions but did not fit the existing theory. For 80 years, these mock theta functions puzzled mathematicians. They were finally understood in the early 21st century by Sander Zwegers and Ken Ono, who showed that they are part of a new class of objects called "mock modular forms." This discovery, rooted in Ramanujan's brilliant intuition, opened up a whole new field of mathematics with applications to black hole physics and string theory.

4. THE RAMANUJAN CONJECTURE

While much of his work was empirical, Ramanujan also made theoretical conjectures of staggering depth. The **Ramanujan conjecture**, concerning the size of the coefficients of the tau function (a type of modular form), is a prime example. It asserts that the coefficients grow in a specific, bounded way. This conjecture not only fueled the development of modern algebraic number theory but also inspired the development of the Langlands program, one of the most ambitious and unifying frameworks in mathematics, which aims to build a "grand unified theory" of mathematics.

The Hardy-Ramanujan Collaboration: A Study in Contrasts

The partnership between Ramanujan and G. H. Hardy is a legendary chapter in the history of science. Hardy was a rigid, logical purist who believed in rigorous proof. Ramanujan was a soft, emotional, and deeply religious man who trusted his intuition. Their collaboration was a perfect match. Hardy provided the

rigorous scaffolding that Ramanujan's raw ideas needed, while Ramanujan supplied an endless stream of results that left Hardy in awe. The famous anecdote of the **taxicab number 1729** perfectly captures their relationship. When Hardy visited the ailing Ramanujan in the hospital, he commented that the number of his taxi, 1729, was "rather a dull one." Ramanujan immediately replied, "No, it is a very interesting number; it is the smallest number expressible as the sum of two cubes in two different ways" ($1729 = 1^3 + 12^3 = 9^3 + 10^3$). This story illustrates Ramanujan's instinctive, deep connection with the personalities of numbers.

The Lost Notebook and Modern Discoveries

After Ramanujan's untimely death at the age of 32 in 1920, his widow returned to India with his notebooks. For decades, mathematicians pored over these pages, which contained thousands of theorems without proofs. While many results were published, a mysterious "lost notebook" was discovered in 1976 by George Andrews in the Wren Library at Cambridge. This box of loose papers

contained the final, feverish work of Ramanujan's last year, including his mock theta functions. The process of deciphering and proving the results in this notebook is still ongoing, and it continues to produce new mathematics. Mathematicians like Bruce Berndt, Ken Ono, and Manjul Bhargava have spent decades verifying and extending Ramanujan's work, often finding that his hints, written in his unique notation, are the seeds of entire modern theories.

It is easy to view Ramanujan's work as abstract and theoretical, but his contributions have found surprising applications.
