# Why Memorizi ng Test Answers Can Be Dangerou s

If you simply memorize the correct responses without understanding the underlying safety principles, you may pass the test but still lack the ability to

identify hazards on an actual site. A real construction environment is dynamic, and a multiple-choice question cannot capture every nuance. # Ethically      Fall

## Protection – The 6-Foot Rule

If you are struggling with a particular topic, it is acceptable to use answer keys as a study aid—provided you go beyond the letter of the answer. Look at the explanation behind the correct choice. For instance, if the question asks about the maximum slope for a ramp used in excavation, learn why the slope must be that ratio (based on soil type and stability) rather than just memorizing 1.5:1. That way, you can apply the same logic to similar safety decisions.

### COMMONLY TESTED CONCEPTS AND SAMPLE EXPLANATIONS

---

Under **OSHA 1926 Subpart M**, fall protection is required for workers at heights of six feet or more above a lower level. This applies to walking/working surfaces, roofs, and scaffolds. The protection can be a guardrail system, safety net, or personal fall arrest system. Why six feet? Because falls from even moderate heights can cause severe injury or death. Understanding this threshold is fundamental.

# Excavation Safety – Protective Systems

## Hazard Communication – GHS Labels and SDS

For excavations five feet or deeper, a protective system (shoring, shielding, sloping, or benching) is generally required unless the excavation is entirely in stable rock. The required slope angle depends on soil classification (Type A, B, or C). Workers should also know that a competent person must inspect excavations daily for signs of cave-ins, water accumulation, or other hazards.

The Globally Harmonized System (GHS) standardizes label elements: pictograms, signal words ("Danger" or "Warning"), hazard statements, and precautionary statements. Every chemical on a construction site must have an up-to-date Safety Data Sheet (SDS) available for review. Workers should be able to locate the SDS and understand

the hazards of the chemicals they handle.

# Personal Protective Equipment – Hard Hats and Eye Protection

Hard hats are required when there is a risk of head injury from falling objects, electrical shocks, or bumps. Eye protection (safety glasses or goggles) must be worn when

there is a risk of flying debris, chemical splash, or harmful light. The employer is responsible for providing PPE and training workers on its proper use.

# Time Management

The exam is typically untimed, but you should still pace yourself. Read each question carefully—some may contain trick wording or double negatives. If you are unsure of an answer, mark the question and return to

it later. Often, other questions will jog your memory.

## Eliminate Wrong Answers

For multiple-choice questions, cross out obviously incorrect options first. This increases your odds of selecting the correct one, even if you have to guess. For example, if a question asks about the maximum distance a ladder can extend above a roof, and one choice is 3 feet, another is 5 feet, and a third is 10 feet, you can eliminate the extreme option based on common knowledge (OSHA requires 3 feet above the landing).

## Stay Calm and Confident

Test anxiety can cloud your thinking. Remember that you have completed 30 hours of instruction. Trust your preparation and take deep breaths. The exam is designed to test basic competence, not to trick you.
