THE FULL TEXT OF THE SAINT FRANCIS OF ASSISI PRAYER

Before we explore its meaning, it is helpful to have the complete text of the prayer before us. There are slight variations in wording across different traditions, but the most widely recognized version is as follows:

Lord, make me an instrument of your peace.
Where there is hatred, let me sow love;
where there is injury, pardon;
where there is doubt, faith;
where there is despair, hope;
where there is darkness, light;
and where there is sadness, joy.

O Divine Master, grant that I may not so much seek
to be consoled as to console;
to be understood as to understand;
to be loved as to love.

For it is in giving that we receive,
it is in pardoning that we are pardoned,
and it is in dying that we are born to eternal life.

UNPACKING THE MEANING: A LINE-BY-LINE REFLECTION

The beauty of the **Saint Francis of Assisi Prayer** lies in its simplicity, but beneath that simplicity lies profound spiritual depth. Let us walk through the prayer and reflect on its meaning for contemporary life.

"Lord, make me an instrument of your peace."

"O Divine Master, grant that I may not so much seek to be consoled as to console."

This is the turning point of the prayer. It shifts our focus from receiving to giving. The natural human instinct is to seek comfort when we are hurting. But Francis, drawing on the example of Christ, inverts this logic. True spiritual maturity is found not in

being served, but in serving. This does not mean our own pain is invalid; it means that we find healing in helping others heal. This principle is supported by modern psychology, which shows that acts of service and compassion are powerful antidotes to depression and anxiety.
