This protection lasts for a specified term (generally the life of the author plus 70 years for works created after 1978, or 95 years from publication for corporate works).

WHY THE COPYRIGHT

EDUCATORS AND STUDENTS

For teachers and students, the copyright notice might seem like a distant legal concept, but it has practical implications every day in the classroom. Understanding these boundaries helps educators use materials legally and ethically while still providing excellent instruction.

Permissible Uses Under Fair Use

United States copyright law includes the doctrine of “fair use,” which allows limited

use of copyrighted materials without permission for purposes such as criticism, comment, news reporting, teaching, scholarship, or research. For educators, fair use can be a valuable tool, but it is not a blanket permission. Courts consider four factors when determining fair use:

1. **The purpose and character of the use:** Is it for nonprofit educational purposes or commercial gain? Educational use is more likely to be considered fair.
2. **The nature of the copyrighted work:** Is the work factual or

creative? Factual works like textbooks may receive less protection than purely creative works.

3. **The amount and substantiality of the portion used:** Using a small, non-central excerpt is more likely to be fair than using a large or central portion.
4. **The effect of the use upon the potential market:** If the use harms the market for the original work, it is less likely to be fair.

In practice, a teacher might be allowed to photocopy a single chapter for classroom discussion, but
