The Texas Jurisprudence Nursing Exam is administered online through the Texas Board of Nursing's website. - **Set up your**

**environment:**

Use a quiet room with no distractions. Have your documents open in separate browser tabs. Ensure your internet connection is stable.

- **Manage your time:** With 50-60 questions in 90 minutes, you have roughly 1.5 to 2 minutes per question. If you get stuck, mark the question and move on. Return to it later if time allows.
- **Read questions carefully:** Some questions are tricky, with "except," "not," or "best" as qualifiers. Pay attention to what

the question is actually asking.

- **Use the open-book wisely:** Do not try to read the entire document during the exam. Instead, look up only what you are unsure about. Trust your prior reading.
- **Double-check your answers:** If you finish early, review any flagged questions. Ensure you have answered every question before submitting.

## Common Mistakes

# and How to Avoid Them
