### Example Clause:

If the Premises is re-rented before the end of the sixty-day notice period, Tenant's obligation to pay Rent shall cease on the date the new tenancy begins. No early termination fee shall be charged if Tenant terminates due to a job relocation of more than fifty (50) miles, provided Tenant submits written verification from the employer. This clause does not relieve Tenant of the obligation to pay for any damages beyond normal wear and tear."

This sample early termination clause of residential lease illustrates a balanced approach. The tenant pays a penalty but is not stuck with indefinite liability. The landlord gets a fee and a notice period while being motivated to find a new occupant quickly.

## HOW TO NEGOTIATE AN EARLY TERMINATION CLAUSE BEFORE SIGNING

The best time to address early termination is before you sign the lease.
