Negative covenants often restrict the company from taking on significant new debt, selling major assets, or changing

Rights, Preferences, and Privileges

This section defines the specific legal rights attached to the investment. For equity investments, it includes voting rights, dividend rights, and liquidation preferences. A liquidation preference is a

crucial protective provision for investors, ensuring they get their money back (or a multiple thereof) before the common stockholders are paid in a sale or dissolution of the company. Exit Strategy and Anti-Dilution Provisions

section outlines the mechanisms for a liquidity event, such as an initial public offering (IPO) or an acquisition (M&A). A solid template will also include anti-dilution provisions. COMMON TYPES OF INVESTMENT TEMPLATES

This is often used in industries with predictable cash flow, such as real estate or established e-commerce businesses.
