## The Greek Origin: Hoper Ed Deixai (ὅπερ ἔδει δεῖξαι)

While the abbreviation QED comes from Latin, the tradition did not start with the Romans. The ultimate origin lies in the golden age of Greek mathematics. The ancient Greek mathematician **Euclid** is generally credited with popularizing the convention in his seminal work, *The Elements*, written around 300 BC. In the original Greek, Euclid concluded his proofs with the phrase **ὅπερ ἔδει δεῖξαι** (Hoper Ed Deixai), which translates directly to "which was required to be proved."
