THE REGULATORY FRAMEWORK GOVERNING HEALTHCARE ADMINISTRATION

Section 1557 of the ACA prohibits discrimination on the basis of race, color, national origin, sex, age, or disability in federally funded health programs, which has implications for language access services and cultural competency training.

Beyond these, the **Stark Law** (Physician Self-Referral Law) prohibits physicians from referring Medicare and Medicaid patients for designated health services to entities with which the physician or an immediate family member has a financial relationship, unless an exception applies. Similarly, the **Anti-Kickback Statute** makes it a criminal offense to knowingly and willfully offer, pay, solicit, or receive remuneration to induce or reward referrals for items or services covered by federal healthcare programs. These laws are central to compliance programs in hospitals and large group practices.

PATIENT RIGHTS AND INFORMED CONSENT

HEALTH INFORMATION PRIVACY AND SECURITY

FRAUD, ABUSE, AND COMPLIANCE PROGRAMS

of Health and Human Services, Office of Inspector General (OIG), has published guidelines outlining the seven elements of an effective compliance program:

- Written policies and procedures, including a code of conduct
- Designation of a compliance officer and compliance committee
- Effective training and education for all employees
- Open lines of communication, such as a hotline for reporting concerns
- Auditing and monitoring to detect potential issues
- Consistent enforcement of standards through disciplinary action
- Prompt response to
