TYPES

The CFA Level 1 exam consists of multiple-choice questions. There are two sessions of 135 minutes each, with a total of 180 questions. The **CFA USA Level 1 syllabus** is tested through three types of questions:

Portfolio Management introduces diversification, asset allocation, risk management, and portfolio performance evaluation. While Level 1 covers the basics, this topic becomes central in later levels.
