FALL PROTECTION

Understand the height thresholds—typically six feet in construction and four feet in general industry—that trigger fall protection requirements. Review the definitions of anchorage points, deceleration distance, and limit the free fall distance. Mastery of this module alone can secure several correct answers.

ELECTRICAL SAFETY

Electrocution is another major hazard, and the exam will test your knowledge of lockout/tagout procedures, ground fault circuit interrupters (GFCIs), and safe work practices near power lines. Questions often

ask about the minimum approach distances for qualified and unqualified persons. Familiarize yourself with the hierarchy of controls: elimination, substitution, engineering controls, administrative controls, and PPE. Knowing when to use a GFCI and how to identify damaged cords is crucial.

The OSHA 30 final exam commonly includes questions on the selection, care, and maintenance of PPE. You need to know the specific standards for hard hats, safety glasses, gloves, and hearing protection. For example, which ANSI

HAZARD COMMUNICATION

HazCom standards—often called the "Right to Know" law—require employers to inform workers about chemical hazards. Expect questions about Safety Data Sheets (SDS), labels, and the Globally Harmonized System (GHS) of classification. Memorize the key sections of an SDS, such as Section 1 (identification) and Section 8 (exposure controls/personal protection). Also understand the

difference between physical hazards (flammability, reactivity) and health hazards (carcinogens, corrosives).

WALKING-WORKING SURFACES AND EMERGENCY ACTION PLANS

Slips, trips, and falls on the same level are also covered. Questions may address housekeeping standards, aisle markings, and the requirements for emergency exit routes. In addition, you should know the elements of a fire prevention plan and an emergency action plan. The course will emphasize the importance of clearly marked exits, evacuation procedures, and alarm systems.

Effective Study Strategies—Beyond Memorizing Answers

RELYING ON "ANSWER KEYS" FOUND ONLINE

OVERLOOKING THE OPEN-BOOK NATURE

OSHA 30 does not expire (except in some states or for certain industries), but best practices evolve. Subscribe to OSHA's newsletter or follow reputable safety blogs to stay current. If your employer offers refresher training, take it seriously.

TEACH OTHERS

Explaining safety concepts to new hires or junior coworkers reinforces your own understanding. It also builds a culture of safety where everyone looks out for one another. You might

even discover gaps in your knowledge that you can fill by revisiting your OSHA materials.
