SAMPLE NOTARY PUBLIC TEST QUESTIONS FOR NORTH CAROLINA

Question 1: Acknowledgment vs. Jurat

Answer: B) Acknowledgment. In an acknowledgment, the signer declares before you that they signed voluntarily, but the signature may have been made earlier. In this scenario, the signer also signs in your presence, which is permitted for acknowledgments, but the key is the declaration of willingness. A jurat, by contrast, requires the signer to swear or affirm the truth of the document’s contents and sign in the notary’s presence.

Question 2: Identifying a Signer

Scenario: A woman approaches you for notarization. She presents a valid North Carolina driver’s license that has expired three weeks ago. You recognize her from a previous notarization two months ago. Can you proceed?

1. A) Yes, because you personally know her
2. B) Yes, because the license is a government-issued ID
3. C) No, because the ID is expired
4. D) No, because you need two forms of identification

Answer: C) No, because the ID is expired. North Carolina law requires acceptable identification to be current (not expired) and issued by a government agency. Personal knowledge is also acceptable, but you must have that knowledge independent of the expired ID. Recognizing someone from a prior transaction does not constitute personal knowledge under the notary statutes unless you have a relationship that would allow you to positively identify them without documentary proof.

Question 3: Notary Journal Requirements

Scenario: You notarize a quitclaim deed for your neighbor. You record the notarization in your journal, including the date, type of notarial act, and the signer’s name. Your neighbor asks you to not include the document type because it is a private matter. What should you do?

1. A) Agree, since the neighbor is a friend
2. B) Record only the minimal information required by law
3. C) Inform your neighbor that you are required by law to record the document type
4. D) Stop the notarization

Answer: C) Inform your neighbor that you are required by law to record the document type. The North Carolina notary journal must contain the date, type of notarial act, the signer’s name and address, the type of document (e.g., deed, power of attorney), and the method used to identify the signer. As a notary, you cannot omit required entries even at the request of the signer.

Question 4: Fees and Prohibited Acts

Scenario: You are employed as a loan officer at a bank. You are asked to notarize a mortgage document for a customer who is also applying for a loan with your bank. Can you perform the notarization?

1. A) Yes, if you do not charge a notary fee
2. B) Yes, because you are a commissioned notary
3. C) No, because you have a financial interest in the transaction
4. D) No, because you are not allowed to notarize for customers

Answer: C) No, because you have a financial interest in the transaction. North Carolina law prohibits a notary from performing a notarial act if the notary is a party to the transaction or has a direct beneficial interest. As a loan officer, your compensation may depend on the loan being approved, giving you a disqualifying interest.

KEY TOPICS COVERED IN NOTARY PUBLIC TEST QUESTIONS FOR NC

Commission Requirements and Renewal

Violations can lead to suspension or revocation of your commission.
