Employers in Southern Nevada are required by law to ensure their food handlers hold a valid health card. If you are caught working without one, both you and your employer can face fines and penalties. That is why it is so important to get your card before you start working.

### WHAT THE SNHD HEALTH CARD TEST COVERS

---

The test is designed to assess your understanding of core food safety concepts. Bacteria grow rapidly in the temperature danger zone, which is between 41°F and 135°F. ### COMMON QUESTIONS ON THE SNHD HEALTH CARD TEST

## Cleaning and Sanitizing

You may be asked about the correct concentration for a sanitizer solution. For chlorine bleach, the typical concentration is 50 to 100 parts per million for most surfaces. You should also know that sanitizer test strips are used to check the concentration and ensure it is in the proper range. Another common question is: "What is the difference between cleaning and sanitizing?" Cleaning removes visible dirt, while sanitizing reduces bacteria to safe levels.

### **WHAT HAPPENS AFTER YOU PASS THE TEST?**

Once you pass the SNHD health card test, you will receive a

temporary certificate that is valid for 30 days. Your official health card will be mailed to you within that timeframe. You must carry your health card with you while working, or have it readily available at your place of employment. The card is valid for one year from the date of issue, and you will need to renew it annually by taking the test again or completing a refresher course, depending on current SNHD requirements.

## Maintaining Your Certification

To keep your certification current, set a reminder to renew your health card before it expires. Many food handlers wait until the last minute, which can lead to lapses in certification. If your card expires, you cannot legally work
