## UNDERSTANDING THE 2012 AP GOVERNMENT MULTIPLE CHOICE SECTION

---

The Advanced Placement U.S. Government and Politics exam has long served as a benchmark for high school students seeking college credit and a deeper understanding of American political institutions. Among the various components of

this exam, the multiple choice section often presents the greatest challenge due to its breadth of content and the analytical thinking required. ## Multiple Choice Section

# National Government: Congress, the Presidency, and the Judiciary

A significant number of questions on the 2012 exam focused on the three branches of government. For Congress, students needed to know the differences between the House of Representatives and

the Senate, including terms of office, constituency size, and the unique powers of each chamber. Questions about the legislative process, such as the role of committees, the filibuster, and the presidential veto, were common. When reviewing possible

The presidency section included questions on formal and informal powers, executive orders, and the role of the president in foreign policy. A typical question might have

# Public Policy and Political Behavior

The public policy portion of the 2012 exam covered economic policy, social welfare policy, and foreign policy. Students were expected to understand the roles of the Federal Reserve, the Congressional Budget Office, and the Office of Management and Budget. Questions about the budget process, fiscal policy, and monetary policy were common. The correct **2012 AP Government**

**multiple choice answers** in this area often required students to differentiate between the tools available to Congress and those available to the president in shaping policy. Additionally, questions about social welfare programs such as Social Security, Medicare, and Medicaid tested students' knowledge of entitlement programs and their political sustainability.

# Multiple Choice
