REAL-WORLD EXAMPLES OF RESTAURANT SOPS IN ACTION

Example 1:

Assembling a Burger

The SOP might instruct: Place the bottom bun on the wrapper. Spread 1 oz of signature sauce. Add 2 pickle chips, 2 tomato slices, and 1 leaf of lettuce. Place the 1/3 lb patty (cooked to 155F internal temp) on the bed of vegetables. Add 1 slice of cheddar cheese. Cap with the top bun, slightly offset. Wrap tightly in the branded paper, tucking the ends under the burger. Place seam-side down on the plate with a side of fries.

Example 2: Greeting a Guest

The SOP might instruct: Make eye contact and smile within 30 seconds of the guest being

seated. Approach the table and say, "Welcome to [Restaurant Name]. I am [Name], and I will be taking care of you this evening. Can I start you off with something to drink?" Do not ask "Are you ready to order?" at the initial greeting. Allow the guest time to settle in.
