One important note: if at any point before the final hearing one spouse changes their mind, the dissolution cannot proceed. In that case, the case is dismissed, and either party may choose to file for divorce instead.

Cost and Timeline of a Dissolution in Ohio

While costs vary depending on attorney fees, court costs, and the complexity of your agreement, many couples find that a dissolution costs significantly less because it requires fewer court appearances, less discovery, and minimal legal maneuvering.

- **Court Filing Fees:** Typically range from \$200 to \$400, depending on the county.

In terms of timeline, the minimum 30-day waiting period means that a dissolution cannot be finalized in less than about a month. In practice, most dissolutions take between 6 and 12 weeks from filing to final hearing, assuming both parties cooperate fully and the court's schedule allows for a timely hearing.

- **Using One Attorney for Both Spouses:** This is strictly

prohibited by Ohio ethics rules. Each spouse must have independent legal representation or choose to proceed without an attorney (pro se). However, proceeding without an attorney is risky, particularly in complex cases.

- **Ignoring Tax Implications:** Property transfers and spousal support can have significant tax consequences. Consult with a tax professional or your attorney to understand how your agreement will affect your tax liability.
- **Failing to Plan for the Future:** A dissolution ends your marriage but may not resolve all future issues, especially if you have children. Ensure your agreement includes provisions for modifying custody or support as circumstances change.

How to Prepare for Your Final Hearing
