INTRODUCTION: THE POWER OF A PERSONAL MISSION

STEP 2: CHOOSE THE RIGHT TYPE OF FOUNDATION

There is no one-size-fits-all answer to **how to start a foundation**. Your choice depends on funding sources, control, and operational complexity. The two main categories are:

Private Foundation

Typically funded by a single source (an individual, family, or corporation). It enjoys tax-exempt status but faces stricter regulatory rules and a mandatory annual payout requirement (usually 5% of net investment assets). Private foundations offer complete control over grantmaking and are ideal for those who want to build a long-term philanthropic vehicle.

Public Charity

Also known as a public foundation, this entity raises funds from multiple sources and must demonstrate broad public support. Public charities have fewer payout requirements and more favorable tax treatment for donors.

For most beginners, a **private non-operating foundation** is the go-to structure. It does not run its own programs but instead provides grants to other nonprofits. If you wish to run programs directly (e.g., a scholarship program or a health clinic), consider a **private operating foundation**. Discuss these options with a qualified attorney to determine what aligns with your goals.

STEP 3: ESTABLISH A LEGAL STRUCTURE AND BOARD OF DIRECTORS

Once you have a mission and type in mind, the next question in *how to start a foundation* involves legal formation. In the United States, you will typically incorporate as a nonprofit corporation in the state where your foundation will be based. This involves:

- Choosing a unique name (check availability with the state’s business division).
- Filing Articles of Incorporation that include your charitable purpose.
- Appointing a board of directors (minimum one person, but three is recommended for grants and oversight).

Your board should include individuals who share your passion and bring diverse expertise – legal, financial, and programmatic. Their primary duties are fiduciary: ensuring the foundation follows its mission, manages assets responsibly, and complies with regulations. Many founders serve as the board chair or president, but it is wise to include independent members to ensure accountability.

STEP 4: DRAFT BYLAWS AND GOVERNANCE POLICIES

Bylaws are the internal rules that dictate how your foundation will operate. They cover meeting frequency, board member terms, voting procedures, and conflict-of-interest policies. Strong governance is essential when learning **how to start a foundation** because the IRS and state regulators will scrutinize these documents. Key elements include:

- Purpose and mission restatement.
- Number and duties of directors.
- Officer positions (president, treasurer, secretary).

STEP 5: APPLY FOR FEDERAL TAX EXEMPTION (501(C)(3) STATUS)

Without IRS recognition of your foundation as a tax-exempt organization, donors cannot deduct contributions, and you will not enjoy the tax benefits of operating a foundation. In the United States, you file **Form 1023** (or the streamlined Form 1023-EZ for smaller foundations with assets under \$250,000) within 27 months of incorporation.

The application requires detailed information about your structure, finances, governance, and planned activities. You must demonstrate that you will operate exclusively for charitable purposes. The IRS approval can take several months, so patience is key. Once approved, you will receive a determination letter confirming your 501(c)(3) status. Keep this document safe; you will need it when opening bank accounts and applying for state-level exemptions.

STEP 6: OBTAIN AN EMPLOYER IDENTIFICATION NUMBER (EIN)

Before filing Form 1023, you need an EIN from the IRS. Think of this as a social security number for your foundation. You can apply online via the IRS website for free. The EIN is used to open a bank account, file annual returns, and report taxes. This step is straightforward but essential as you continue learning **how to start a foundation** from a financial perspective.

STEP 7: CREATE A FUNDING AND INVESTMENT PLAN

A foundation without assets is just an idea. You must transfer funds, property, or other assets to the foundation. Common funding sources include personal wealth, proceeds from a business sale, or family contributions. Once assets are in place, decide how they will be managed:

- **Endowment model:** Invest the principal and use only the earnings for grants. This ensures perpetuity.
- **Spend-down model:** Use both principal and earnings over a set period (often during the founder's lifetime). This maximizes immediate impact.

Engage a financial advisor experienced in philanthropic investment. They can help you create a portfolio that balances growth and liquidity while complying with the mandatory payout requirement. Document your investment policy in writing to guide future board decisions.

STEP 8: SET UP OPERATIONAL PROCEDURES

Now that the legal and financial foundations are in place, focus on day-to-day operations. For a small foundation, the founder may act as the sole staff member. But even minimal administration requires clear processes:

Grantmaking Guidelines

Decide how you will find and vet grantees. Will you accept unsolicited applications, or will you invite proposals? Create a simple application form, define evaluation criteria, and set a timeline for review. Many foundations focus on a few high-impact grants rather than many small ones.

Record Keeping and Compliance

Maintain meticulous records of all financial transactions, board meeting minutes, and grant decisions. Private foundations must file **Form 990-PF** annually with the IRS, which is publicly available. This form details your assets, grants, and compensation. Noncompliance can lead to penalties or revocation of tax exemption.

Communication and Transparency

While private foundations are not required to have a public website, transparency builds trust. Consider creating a simple site that states your mission, grant guidelines, and list of recent grants. This also helps potential applicants find you.

STEP 9: UNDERSTAND ONGOING RESPONSIBILITIES

Starting is just the beginning. A foundation requires continuous attention to remain effective and compliant. Key ongoing duties include:

- **Annual payout:** Distribute at least 5% of the average net investment assets each year.
- **Self-dealing rules:** Avoid transactions with disqualified persons (e.g., you, your family, board members) that benefit them personally.
- **Excess business holdings:** Private foundations generally cannot own more than 20% of a for-profit business.
- **State filings:** Many states require registration or annual reports for charitable organizations operating within their borders.

Ignoring these rules can result in excise taxes or loss of exemption. That is why many founders work with a part-time accountant or hire a foundation management service.

STEP 10: EVALUATE IMPACT AND ADAPT

The final piece of **how to start a foundation** involves measuring success. Without evaluation, you may be writing checks without knowing if they matter. Define metrics that align with your mission – such as number of students graduating, acres of land conserved, or research papers published. Regularly ask your grantees for progress reports and visit projects when possible.
