The most efficient strategy is to treat the entire ion as a single unit if it appears unchanged on both sides of the equation. Students initially struggle with this higher-level thinking.
4. **Translation Errors in Word Problems:** Even strong students can struggle to translate a word description into a correct chemical formula. For example, writing "carbon monoxide" as CO (correct) versus Co (cobalt). This requires a solid foundation in nomenclature before the conservation law can even be applied.

## INTEGRATING HANDS-ON EXPERIMENTS WITH WORKSHEETS

### **ADAPTING WORKSHEETS FOR DIFFERENT GRADE LEVELS**
